

etc. In cash or by money order. Cash doesn't have your name on it & you do not have to put your correct name on a money order.

54. "IF YOU NEED A TELEPHONE, TRY TO GET IT UNLISTED IN AN ALTERNATE NAME just giving them the correct address. Better yet, rent a place that already has a phone in the owner's name, or ask the owner to have it installed in his name.

55. "SET UP A 'LEGAL' ADDRESS SOMEWHERE ELSE, even if it is just the closet in a friend's house, containing some misleading personal effects. He can then point to something if ever questioned, but of course he doesn't know when you are returning from India..."

56. "USE THIS 'LEGAL' ADDRESS FOR ALL SUBSEQUENT DEALINGS WITH THE SYSTEM. KEEP THE ADDRESS OF WHERE YOU ACTUALLY LIVE A WELL-GUARDED SECRET, & ONLY LET THOSE WHO ARE TRUSTWORTHY & REALLY NEED TO KNOW YOUR ACTUAL ADDRESS. Subsequently, keep your job, personal activities & hobbies well separated & self-contained so that heat in one area will not endanger any of the others."

57. "IF MINOR CHILDREN ARE INVOLVED IN YOUR DISAPPEARING ACT, you might have to get them to accept a new surname. Be serious about it & they should understand. It would normally be best not to give them advance warning of your move so that they cannot tell all their friends & schoolmates. Once you move, have them start using their new names right away, as they will need to get used to them if you plan on enrolling them in a new school. If this is your plan, you will have to give serious thought to obtaining good solid alternate ID, which will undoubtedly be required by the school authorities.

58. "ALTERNATIVELY, IF YOU HAVE SCHOOL AGE CHILDREN & YOU DO NOT WANT THEM TO ATTEND PUBLIC SCHOOLS, YOU CAN:  
a) Find a suitable private school.  
b) Tell neighbours that the children are feeble-minded & that you are tutoring them at home.  
c) Tell the inquisitive that you are a transient visitor from Mississippi, Virginia or South Carolina, states which have repealed compulsory attendance laws.  
d) Move every three months to prevent rumours from spreading too far.  
e) Keep the children under cover during school hours."

quests for information that we receive are actually backed up by any punishment. Two basic steps to take in making yourself harder to locate are to get a PO box & an unlisted telephone number."

#### CONFUSE A COMPUTER

79. "COMPUTERS ARE NOT A CHINESE INVENTION, BUT IT'S GOOD TO SPEAK CHINESE TO THEM AS MUCH AS POSSIBLE. One of the bureaucrat's primary tools is the electronic computer with its enormous files of information on everything under the sun, including people. Actually the computer's omniscience is more a myth than reality & is extremely easy to confuse if you're willing to take the time to do it.

80. "FOR EXAMPLE, MOST COMPUTERS ARE INCAPABLE OF RECOGNISING THE SAME PERSON UNDER TWO DIFFERENT NAMES, as to a computer 'John R. Jones' & 'J.R. Jones' are different people entirely, & neither is the same as 'J. Robert Jones'.

81. "ESSENTIALLY WHAT YOU ARE TRYING TO DO IS MAKE IT HARD FOR THE BUREAUCRATS & THEIR COMPUTERS TO FOCUS ON YOU. For the bureaucrats to pick you out of the millions of people in this country is something like the old-fashioned process of homing on a radio signal. Their several receivers had to take a fix on the signal from different directions & the lines from those receivers to the transmitter would be plotted. Where those lines crossed would be the transmitters location. In the same way bureaucrats usually need more than one source of information on you to get the fix, & by using different names you blur the focus.

82. "THIS PROCESS CAN BE EXPANDED BY THE SIMPLE EXPEDIENT OF MAKING A FEW 'MISTAKES' every time you have contact with the government. What happens if you give the wrong street address, or change one or two numbers of your social security number when you put them on a form? Unless it is for tax or social security purposes, the answer is usually nothing, & if someone does make a point of it, you just say that you made a mistake & give them the correct information.

83. "IN MANY CASES, THESE MISTAKES ARE JUST INSURANCE & don't give any benefits, but just make you harder to track down. If your drivers license carries one form of your name, & address, your social security another, you live at a third address & receive your mail at still another, you're going to be a very difficult person to locate, much less harass.

84. "YOU CAN EXTEND THIS PRINCIPLE MUCH

#### LEGAL AFFAIRS

59. "IF YOU WANT TO DISAPPEAR, BUT ARE IN THE PROCESS OF BUYING OR SELLING A HOUSE OR SOMETHING ELSE OF CONSIDERABLE VALUE, arrange to have an attorney handle the sale & escrow. Wealthy people have always used smart attorneys to cover their moves, so why not you? Attorneys can be counted on to follow their clients instructions & are quite careful about not divulging information to third parties. Short of a court order, data relating to their clients is considered private & privileged. Be sure to instruct your attorney in the manner of forwarding funds to you.

60. "HE SHOULD BE ABLE TO HANDLE ALL IMPORTANT LEGAL AFFAIRS FOR YOU, providing that you give him the power of attorney for that purpose. So be sure to pay him well for his services, as he will be a vital link between your old & new life. If other methods of investigation fail, pressure will probably be put on him for information, so keep him on your side.

61. "AN ATTORNEY CAN ALSO HANDLE ANY TRANSACTIONS PERTAINING TO A WILL OR ESTATE OF WHICH YOU ARE A BENEFICIARY, as these can sometimes drag on for several years before they are finally settled. He might have to know your actual address, but it should not bother him that you wish a little privacy. Attorneys should be used."

#### ALTERNATE TO

62. "FIRST OF ALL, DON'T BE WORRIED ABOUT BEING TRACKED DOWN BY YOUR PHOTO, as this is only done with notorious criminals who have a price on their head when the great expense & time involved are justified. The FBI admits that at any one time there are about 75,000 fugitives in the U.S., so the Post Office photos can't be working that well, can they?"

63. AS MENTIONED EARLIER, THE AUTHOR ADVOCATES HAVING ALTERNATE ID ON HAND as it's "plainly comfortable to have the option to cut & run, even if you choose not to. It should be done before you get into trouble, or plan to move & disappear, & properly thought out & executed. In an emergency many other matters will compete for your time, & as well in the future, first class ID may be hard to obtain as well.

64. "THE BEST ID TO OBTAIN IS GOVERNMENT ISSUED ID, the most important of which is a social security card, which can be ultimately used to obtain a passport. Forged states or counterfeit ID is a serious matter."

fronts that you can appear to be several different people. The law generally prohibits using assumed names for illegal purposes, but sowing bureaucratic confusion is not against the law.

85. "BY APPLYING THESE TECHNIQUES YOU CAN BECOME EFFECTIVELY INVISIBLE TO THE BUREAUCRACY BY BEING TOO VISIBLE. Too many parts of you will be visible under too many identities & it will take a major investigative effort for the government to find the real you. All this may sound silly or childish, not to mention being a lot of work for very little gain, but it will make very good sense when bureaucrats are crawling through society like termites in the wall of an old house."

#### DON'T FLAUNT IT--STAY INCONSPICUOUS

86. "BEING INCONSPICUOUS SHOULD EXTEND TO YOUR PERSONAL LIFE, as if you're doing well when times are tough, you don't want to advertise it, possibly arousing the resentment & interest of criminals & bureaucrats alike. In a Chinese city you can't tell the houses of the rich from the houses of the poor, as both present the same blank facade to the street. The difference is that the rich man's house might occupy an entire city block & have magnificent gardens & beautiful rooms, while the poor man lives in a single room."

87. TO SUPPLEMENT YOUR ALTERNATE ID, which ever type you have chosen, you can order easily through various mail order houses, school diplomas, certificates & degrees. Legal: Once you have disappeared, it would be a good practice to do without a bank account, as it will take expert alternate ID to open one under an alias.

#### LIVING FREE

88. "IN GENERAL IT IS BEST TO LIVE IN A LARGE CITY where you can have the protection of anonymity. Avoid small towns where the only sport is gossip--about you. Your business should be no one else's."

89. HOUSING: WHENEVER POSSIBLE, TRY TO RENT YOUR HOUSING USING AN ALIAS. When you do rent, change the locks on the doors, & don't give a key to the landlord, as in this manner you can avoid having unwelcome visitors go through your things while you are out. Any 'selah' papers etc., should be kept locked up & out of sight from the casual visitor or snoop. Misleading, innocent items can be left out in the open for all to see.

However, if you cannot obtain this, you can accumulate a variety of types of privately issued ID, which can serve in many situations as protection from harassment.

65. AMONGST THESE FORMS OF PRIVATELY ISSUED IDs, there are a large variety advertised in such national Tabloids as "Midnight", "The National Enquirer", etc. These include birth certificates, which can easily be copied, & ID cards. The author also recommends reading The Paper Trip 2, available from Eden Press, which deals with this subject of how to create, with a little imagination, a whole set of ID.

66. SUCH ID, ALTHOUGH NOT GOVERNMENT ISSUED, CAN STILL BE A HELP IN OBTAINING FOREIGN CITIZENSHIP PAPERS, as many countries do not have such rigid controls as the U.S. & their documents can be duplicated or "bought" more easily, as many international businessmen can testify. In many cases it simply suffices to know the right "ministers" in the government.

67. MANY PEOPLE IN THE FAMILY HAVE FOUND THAT YOU CAN OBTAIN DO A LOT WITH A SIMPLE ALIAS, & some have even rented houses etc. in this manner. By this we mean, for example, that if your name is John Smith, that for casual day to day business, when there is no real need or obligation to give your full name, you present yourself as "Mr. John". If you look respectable, people will very seldom challenge you for ID.

68. THIS CAN BE VERY HELPFUL IN KEEPING YOUR FULL LEGAL NAME OUT OF THE PUBLIC LIGHT, & only known by those who have to & have a right to know, such as government & law officers. Again, be prayerful & you could find that this simple method could be surprisingly effective. It's just such a form of elementary camouflage that the author has in mind when he uses the term "alias".

69. ANOTHER SIMPLE PRACTICE THAT SEEMS TO REALLY IMPRESS SYSTEMITIS IS THE USE OF BUSINESS OR VISITING CARDS. If presented in the proper manner, they seem to confer instant respectability on you in the eyes of officials, agents etc. You can even get away with just having your name on it, or if you have a foreign address you can print that on it, as long as it doesn't endanger anybody's security at that address. Family members have found them to be particularly useful in establishing credibility as most of us do not have the usual system credentials, such as

71. "THINKING CHINESE"--Excerpts from HOW TO SURVIVE & PROSPER IN THE NEXT AMERICAN DEPRESSION, WAR OR REVOLUTION published 1978 by Financial Management Associates, Phoenix, Arizona.

72. "ONE OF THE BIGGEST CHANGES BETWEEN THIS DEPRESSION & THE LAST IS GOING TO BE THE PLETHORA OF BUREAUCRATS & rules that everyone is going to be saddled with. Another important difference is going to be the higher level of violence that we can all expect.

73. "THIS IS GOING TO COMPLICATE EVERYONE'S LIFE, as things will be more difficult & harder to get done. There will be more & more blocks put in the way of law-abiding citizens while criminal activity & random violence will mushroom.

74. "SOME PEOPLES HAVE LIVED WITH SUCH SITUATIONS FOR HUNDREDS OF YEARS & learned to deal with it very effectively, the most outstanding example probably being the Chinese culture that existed before the Communists conquered the country.

75. "FOR THOUSANDS OF YEARS THE CHINESE LIVED UNDER WHAT ONE HISTORIAN CALLED A 'FEUDAL BUREAUCRACY', a massive government structure that sought to regulate every detail of one's life while being unable to control banditry & rampant lawlessness. The Chinese learned to protect themselves from the government as well as from criminals in a remarkably efficient fashion, & their methods bear examination.

#### INFORMATION CONTROL

76. "THE CHINESE LEARNED NEVER TO GIVE OUT INFORMATION ABOUT THEMSELVES OR THEIR AFFAIRS, if they could possibly help it, as they realised that what the government didn't know about, it couldn't prevent. They also realised that even casual conversation had a way of reaching ears that they were not meant for.

77. "AMERICANS, ON THE OTHER HAND, BRAG & GOSSIP ABOUT THEIR AFFAIRS INCESSANTLY, & feel compelled to answer any question anyone puts us. We spend hours filling out forms & cards asking for information about our affairs, no question being too personal if it is put by an official.

78. "WITH AN EVER-GROWING & INCREASINGLY PESTIFEROUS BUREAUCRACY THIS IS NOT A SUBVITAL TRAIT. A good rule is never to talk about your affairs to anyone."

calling at your newsboy's & other home delivery men will be noticed by neighbours, & could be fertile leads for future snoops about your habits at home.

96. "NEVER ORDER UTILITIES IN YOUR REAL NAME, as utility companies are the first watering hole for snoops.

97. "WHEN GOING FROM THE OLD YOU TO THE NEW YOU, IT IS USUALLY A GOOD IDEA TO DROP ANY OLD HOBBIES that could provide the basis for a stakeout of your possible activities. Changing activities can be an excellent way of building your new identity, & will help your old ways to fade faster."

98. AVOID PUTTING YOUR NAME ON DOORBELLS OR MAILBOXES AVAILABLE FOR ALL TO SEE. A very good, inexpensive security device is a "fish eye lense" that can be installed in your front door, enabling you to see exactly who is there before you open the door or go out. Never open the door until you know exactly who is there & that they are friendly.

#### NEIGHBOURS

99. "J. EDGAR HOOVER STATED MANY TIMES THAT FULLY 90% OF ALL ARRESTS BY THE FBI ARE DUE DIRECTLY TO THE 'HELPFUL CO-OPERATION' OF NEIGHBOURS & RELATIVES. Need we say more? Your neighbours are the most dangerous people that you know, & you can include relatives here too. They will all snitch without compunction, & consider it fair sport to call the cops. Be friendly with them, but on your own terms, superficially nice, but in reality have as little to do with them as possible. Ideally you don't want them to know anything about you.



100. "AVOID RUN-INS WITH THEM, OR ANTAGONISING THEM by throwing wild late night parties, as an old unresolved grudge might be just the spark that sends an investigator to your new location. Getting even is a passion that few people can resist. Never tell neighbours where or for



GLASS CURTAINS on all your windows. During the daylight hours, they allow the light to pass freely into the room, while at the same time reflecting some back, appearing to outsiders as a white opaque curtain, preventing them from seeing inside. You can see out, but they can't see in. One word of caution--if you have a light on in the room, the process is reversed--they can see in but it is harder for you to see out!

91. WHEN IT GETS SO DARK THAT YOU NEED TO TURN ON INSIDE LIGHTS, as a security measure, you should either draw solid curtains, or close your shutters. This should be a standard security practice for all families, to avoid unwelcome spying eyes watching you, or a crackpot enemy being tempted to take a pot shot at you.

92. "IF YOU HAVE ANY DOUBTS ABOUT THE SECURITY OF YOUR DWELLING WHILE YOU ARE OUT, take the precaution of putting a hair across a doorway, matches on top of the door etc., & be observant of items being moved. When choosing locks, be sure that they are of good quality, & not too common in your area.

93. "IN CHOOSING A DWELLING, RENT A HOUSE OR APARTMENT THAT APPEARS TO BE RESPECTABLE, BUT NOT MORE SO THAN THE AVERAGE COP COULD AFFORD. In general your standard of living should be lower middle-class, avoiding the attention given to the very rich & very poor. If you must 'live it up', try to do it somewhere other than where you live & work...Try Tokyo, Fiji, Monte Carlo..."

#### HOME LIVING HABITS

94. "THE CARDINAL RULE TO FOLLOW IS NOT TO BE OBVIOUS ABOUT YOUR LIVING HABITS. Turn lights off at a decent hour, keep stereo music from annoying neighbours (Hold your stereo down to 'mood level' late at night. Not everyone mells out with Led Zeppelin or the Stones). Keep your porch & driveway clear & tidy & don't have pets that stray or annoy. (Better yet, don't have any pets, period.)

95. "DON'T HAVE MILK, NEWSPAPERS OR OTHER ITEMS DELIVERED TO YOU ON A REGULAR
